The Wave II is the second generation of touch free mobile cleaning. Compact and self contained, the Wave II, makes this unit easy to transport and maneuver in rest rooms and tight spaces.

The Wave II allows up to four Multi-Task two liter containers to be dispensed along with an option to rinse, or use four chemicals without the rinse option.

Flow rate is 1/2 GPM(2 liters/ minute) giving a run time of 16 minutes per eight gallon tank of water.
